FULBRIGHT OPPORTUNITY IN LAW

ELIGIBILITY

- Must be an Irish Citizen, or an E.U. citizen who has lived in the Republic of Ireland for 3+ years
- Must be a prospective postgraduate student with a minimum 2.1 undergraduate degree in Law and a clear course of study
- Leadership qualities and potential are essential, as well as a clear understanding of what it means to be a Fulbrighter
- Must *not* be a dual U.S.-Irish citizen, green card holder, or currently living in the U.S.
- Must *not* already have extensive experience of studying or living in the U.S.

All applications are due by 4pm Tuesday, 6 November 2018

FUNDING DETAILS

- A \$25,000 grant from the University of Pennsylvania for its LL.M. program. You must be able to complete the entire length of the LL.M. program. (Penn Law's grant is contingent on accepting the Fulbright)
- Monetary grant from the Fulbright Commission, plus accident and emergency insurance, cultural and professional programming, and J-1 visa administration from the Fulbright Program

ANYTHING ELSE YOU SHOULD KNOW?

- All successful applicants must comply with the two-year home rule, which means that awardees will not be eligible for U.S. residency or a visa until the two-year home rule in Ireland is complete.
- The successful candidate will be responsible for the remaining tuition and fees.
